RELEASE OF LIABILITY

In consideration of my being permitted to participate in, or in consideration of my child being permitted to participate in, equestrian activities made available to students enrolled at Monte Vista Christian School, and any activities incidental to and/or connected therewith, including travel to or from said activities, (the "Activities"), I hereby agree as follows:

FULL AND EXPRESS RELEASE OF ALL LIABILITY: I hereby release the School (including its employees, directors, volunteers, agents, persons performing contract services and any other representatives – collectively the "School") from all liability, and waive my right to sue the School for any claims relating to participation in the Activities, including claims of the School's negligence, resulting in any injury of any nature (including death), or economic loss, which I (or my child) may suffer or which may result from my (or my child's) participation in the Activities. _____ [initial]

FULL AND EXPRESS ASSUMPTION OF ALL RISK: I am (or I am permitting my child to) voluntarily participate(ing) in the Activities.
